Before me, the undersigned Assistant District Attorney of Harris County, Texas, this day appeared the undersigned affiant, who under oath says that he has good reason to believe and does believe that in Harris County, Texas, VINCENT TREVON SANDERS, hereafter styled the Defendant, heretofore on or about **October 27, 2019**, did then and there unlawfully, intentionally and knowingly possess a controlled substance, namely, Fentanyl, weighing less than one gram by aggregate weight, including any adulterants and dilutants.

Before the commission of the offense alleged above, (hereafter styled the primary offense, on April 15, 2003, in Cause Number 37,305, in the 268th District Court of Fort Bend County, Texas, the Defendant was convicted of the felony offense of Burglary of a Habitation.

Before the commission of the primary offense, and after the conviction in Cause Number 37,305 was final, the Defendant committed the felony offense of Unlawful Possession of firearm by felon and was finally convicted of that offense on May 11, 2007, in Cause Number 45817, in the 434th District Court of Fort Bend County, Texas.

Probable Cause

AFFIANT, L. VALLE II, IS A CREDIBLE AND RELIABLE PERSON WHO IS REPUTABLY EMPLOYED AS A PEACE OFFICER WITH HOUSTON POLICE DEPARTMENT. AFFIANT HAS REASON TO BELIEVE AND DOES BELIEVE THAT VINCENT TREVON SANDERS (DOB 09/15/1984), HEREINAFTER THE DEFENDANT, COMMITTED THE FELONY OFFENSE OF POSSESSION OF A CONTROLLED SUBSTANCE ON OCTOBER 27, 2019, LOCATED AT 8800 MARTIN LUTHER KING BOULEVARD, HOUSTON, HARRIS COUNTY, TEXAS.

AFFIANT'S BELIEF IS BASED ON THE FOLLOWING:

AFFIANT RECEIVED THIS CASE FOR FOLLOW UP INVESTIGATION REGARDING FENTANYL. THE DEFENDANT WAS OPERATING A MOTOR VEHICLE (WHITE LEXUS) THAT WAS BEARING A LICENCE PLATE OF "05063C7". OFFICER RODRIGUEZ AND OFFICER PASSARELLA "RAN" THE PLATES VIA THE HPD COMPUTER SYSTEM AND LEARNED THE PLATES DID NOT COME BACK TO ANY VEHICLE.

OFFICERS RODRIGUEZ AND PASSARELLA THEN CONDUCTED A TRAFFIC STOP AND ASKED THE DEFENDANT IF THEY COULD SEARCH THE VEHICLE. THE OFFICERS STATED IN THEIR REPORT THAT THE DEFENDANT GAVE CONSENT.

OFFICER PASSARELLA FOUND A SINGLE WHITE CAPSULE WITH "M367" MARKING ON THE CAPSULE IN A SINGLE BAGGY IN THE CENTER CONSOLE OF THE VEHICLE.

OFFICERS ARRESTED AND CHARGED THE DEFENDANT FOR POSSESSION OF A CONTROLLED SUBSTANCE BELEIVING THE PILL THAT WAS MARKED "M367" WAS HYDROCODONE.


