The duly organized Grand Jury of Harris County, Texas, presents in the District Court of Harris County, Texas, that in Harris County, Texas, **VINCENT TREVON SANDERS, ALSO KNOWN AS SANDERS, VINCENT** Thereafter styled the Defendant, heretofore on or about **August 16, 2021**, did then and there unlawfully, while in the course of committing and attempting to commit the burglary of a habitation owned by James Patrick Jeffery, intentionally cause the death of James Patrick Jeffery by striking Complainant with a hammer.

It is further presented that in Harris County, Texas, VINCENT TREVON SANDERS, hereafter styled the Defendant, heretofore on or about August 16, 2021, did then and there unlawfully, while in the course of committing and attempting to commit the burglary of a habitation owned by James Patrick Jeffery, intentionally cause the death of James Patrick Jeffery by a metal bar.

It is further presented that in Harris County, Texas, VINCENT TREVON SANDERS, hereafter styled the Defendant, heretofore on or about August 16, 2021, did then and there unlawfully, while in the course of committing and attempting to commit the burglary of a habitation owned by James Patrick Jeffery, intentionally cause the death of James Patrick Jeffery by striking Complainant with an unknown object.

Before the commission of the offense alleged above, (hereafter styled the primary offense), on April 15, 2003, in Cause Number 37305, in the 268th District Court of Fort Bend County, Texas, the Defendant was convicted of the felony offense of Burglary of a Habitation.

Before the commission of the primary offense, and after the conviction in Cause Number 37305 was final, the Defendant committed the felony offense of Burglary of a Habitation and was finally convicted of that offense on October 8, 2004, in Cause Number 39589, in the 240th District Court of Fort Bend County, Texas.
